Air: Is Independent and arranged by Tour Participants only. International Curtain Call ("ICC") is not responsible for any Air Arrangements.

Deposit & Payment: Deposit of **\$2,000/person plus Single Supplement** charge must accompany all Tour Applications.

Balance of Tour Land Price is due:

England Festivals – 50% February 18; Final Balance April 3, 2023
Italy Festivals – 50% February 28; Final Balance April 15, 2023

ALL LAND PRICE DEPOSITS & PAYMENTS PAID IN CASH (CHECK) TO: INTERNATIONAL CURTAIN CALL (ICC) at the address listed above.

CANCELLATIONS: Cancellations 120 days or more before departure – refund, less administration charge of \$750/person; 119-90 days before departure – refund less 35% of Land Price; 89-45 days before departure—refund less 50% of Land Price; Less than 45 days in advance of departure – entire Price charged unless space resold.

Note: Above refund policy does not apply to any Reservation Fee made prior to above Booking Application, none of which is refundable except as per such Reservation's terms.

Cancellations must be in writing and take effect on receipt. No refunds can be made for tours, meals, sight-seeing, transfers, theater tickets, accommodations or other services included, which for reasons of illness, cancellations or otherwise were not utilized.

Responsibility: INTERNATIONAL CURTAIN CALL and/or its associated companies, principals or agents act only in the capacity of agents for the passengers in all matters of transportation, tour operations and other services.

All receipts, tickets, vouchers, coupons or exchange orders are issued subject to the terms and conditions under which transportation and other services are provided; and ICC, and its associated companies or agents assume no liability for injury, damage, loss, accident, delay or irregularity that may be caused to person or property, either by defect in a vehicle or for any reason whatsoever, or through the acts or default of any company or persons engaged in conveying the passenger or in carrying out the arrangements of the tour.

All such losses or expenses will be borne by the passenger as tour rates provide for arrangements only for the time stated.

The right is reserved to substitute hotels of similar category, change named guides, change the itinerary where deemed necessary, and to cancel the tour prior to departure, in which case, full refund constitutes full settlement to the passenger.

Listed Performances and Casts are subject to change. No refunds shall be made for any change of casts or performances; or performance tickets obtained in other sections of theater if unavailable in Orchestra section. If tickets are unavailable for a performance, refund will be made for ICC's Budgeted cost of same.

Baggage is at owner's risk entirely. The issuance and acceptance of voucher or ticket as well as the signing of the Tour Application shall be deemed to be consent to the above conditions.

All arrangements for land accommodations, transportation, sight-seeing and performance tickets are made by ICC.

Prices are subject to change for: currency exchange fluctuations (after December 1, 2022); or increased costs due to a smaller group than 10.

Alternate excursions may be substituted at ICC's discretion if the group members so elect, or have been on planned excursions before.
